Nepal Rastra Bank Siddharthanagar Office invites sealed bids from eligible bidders for the procurement of Partition Works for **Banking (Cash and General), Library, Store and Currency Management Unit** of Siddharthanagar office<sup>1</sup> under National Competitive Bidding procedures. Only eligible bidders should participate in this bidding. The estimated cost for the work is **Rs. 21, 24,600.04 (Excluding VAT)**.

A complete set of Bidding Documents may be purchased from Nepal Rastra Bank Siddharthanagar Office, by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of Rs 3000 till 2076/10/12. If so requested, the Bidding Documents can also be sent by post/courier services upon payment of required courier charges. However, the Employer will not be responsible for delay or non-delivery of the documents so sent.
4. Pre-bid meeting shall be held at Nepal Rastra Bank Siddharthanagar Office at 2:00 pm on 2076/10/02.
5. Sealed bids must be submitted to Nepal Rastra Bank Siddharthanagar Office by hand/courier on or before 12:00 Noon on 2076/10/13 Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' authorized representatives who choose to attend at 12:30 PM on 2076/10/13 at Nepal Rastra Bank Siddharthanagar Office. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security amounting to Rs 63,000. Which shall be valid for 30 days beyond the validity period of the bid (2077/02/12).
7. If the last date of purchasing and /or submission falls on a public holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
8. Nepal Rastra Bank reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
